Few mechanical errors are present. Suitable language choice and sentence structure are used.

**3. Approaching**

5.2 points

Occasional mechanical errors are present. Language choice is generally appropriate. Varied sentence structure is attempted.

**2. Insufficient**

3.25 points

Frequent and repetitive mechanical errors are present. Inconsistencies in language choice or sentence structure are recurrent.

**1. Unsatisfactory**

0 points

Errors in grammar or syntax are pervasive and impede meaning. Incorrect language choice or sentence structure errors are found throughout.

**▼ Format/Documentation**

6.5 points

**Criteria Description**

Uses appropriate style, such as APA, MLA, etc., for college, subject, and level; documents sources using citations, footnotes, references, bibliography, etc., appropriate to assignment and discipline.

**5. Target**

6.5 points

No errors in formatting or documentation are present. Selectivity in the use of direct quotations and synthesis of sources is demonstrated.

**4. Acceptable**

5.85 points

Appropriate format and documentation are used with only minor errors.

3.25 points

Appropriate format is attempted, but some elements are missing. Frequent errors in documentation of sources are evident.
